We remain a dynamic organisation, continuing to grow and evolve as we work to improve our service delivery and build our supporter base.

As the Senior Leadership team continues to implement the 2021 Strategic Plan, we are seeing growth and improvement across the organisation.

Financially, I am pleased to report that the organisation is in a very sound position, with all Budget objectives for 2018/19 having been met, and our investment reserves performing well.

What is most pleasing is that as the organisation continues to grow, the services we offer to clients continues to expand as well. This year, we launched our Lifestyle and Leisure program, which gives people who are blind and vision impaired the chance to learn basic cooking, self-defence and pottery skills.

One of the Board's priorities has been to ensure we make maximum use of all dogs that are bred and trained here at Guide Dogs Queensland. We were delighted to relaunch the Pets as Therapy Program in May 2019 giving dogs that don't make it in our Guide Dog program a different career path and a second chance at changing lives.


There were a number of key changes to our Board membership this year. We welcomed two new directors -David Swain and Corinne Butler - each offering fresh perspective and diversity to our Board.

A message from our Patron

As Patron of Guide Dogs Queensland, it gives me great pleasure to write once again in support of this warmly uplifting **Oueensland institution.**

I have always been amazed, frankly, at the scope of Guide Dogs Queensland support. While the iconic Guide Dog neatly conveys to the public the organisation's core mission of supporting people with vision loss, its true community impact extends beyond these bounds.

I was intrigued to learn of the 'Pets as Therapy' program

launched in 2018 to give pups who are not suited to becoming Guide Dogs a second chance at changing lives. In 2019 the first therapy dog, 'Esme', was placed with Artie, a five-year-old boy with severe autism, to beneficial ends.

This year, Guide Dogs Queensland handlers were the first in Australia to trial new harness technology, enhancing both handler and Guide Dog comfort. This is another glittering example of Guide Dogs Queensland's enduring relevance and commitment to innovation.



CEO's Message

This year we have seen success and growth across the organisation, as we work towards building positive foundations for the future.

I sincerely thank our President Richard Anderson, Vice President Leanne Muller, the Board and the Senior Leadership team and staff for their ongoing commitment to ensuring we provide the best service for people living with low or no vision.

Teams across the organisation have had a productive year and we are continuing to build our Client Services team, welcoming three Occupational Therapists and a new Allied Support Services Manager on board. Over the past financial year, we conducted 111 regional visits, which included our attendance at 10 regional disability expos, and provided assistance to more than 600 clients.

Our Guide Dog Services team have placed a record 27 Guide Dogs over the past financial year and our breeding program

continues to thrive, with 81 puppies born in the Nursery. With the new vet clinic due for completion by January 2020, we will be able to provide all care for our colony on site.

Our Support Services team has been working to develop robust systems, processes and improved risk management. The team is working hard to make documents and forms accessible across the organisation, with all staff taking part in specialised training programs.

I'm extremely grateful to our incredible community for their support in our fundraising initiatives, particularly the many Oueenslanders who participated in Pawgust – our new national fundraising campaign. More than 1,000 people registered, raising \$600,000 in the process.

As Patron, I thank the Board, staff, volunteers and donors for supporting this important Queensland institution. I wholeheartedly congratulate the organisation on their advocacy and efforts to support people in our community to be independent and to achieve their goals.

Finally, I thank everyone who aided the 'Miracle Litter' born prematurely in 2019. Thanks to their care, these puppies have the chance to grow into lifechanging Guide Dogs and continue the important work of Guide Dogs Queensland.

A number of significant improvements were made to the Nursery and Training Centre at Bald Hills this year, including the completion of the Memorial Garden, which is a dedicated space to acknowledge those who have left a generous Legacy gift in their Will, as well as honouring past working Guide Dogs. Work was also completed on a new multi-purpose centre behind client residence which will be used for a variety of client-based activities, including the Early Learning Centre which is due to re-open at the end of 2019.

We continue to work to build a healthy culture for staff and volunteers, with the implementation of new workplace wellness initiatives and a focus on improving volunteer satisfaction. Our most recent volunteer survey recorded a 91 per cent satisfaction rate. We remain focused on supporter and staff engagement to ensure we can continue to provide our vital services to those who need it.
